

- 1. Nagar Nigam Greater Jaipur invites online bids through www.eproc.rajasthan.gov.in for following works from the bidders fulfilling eligibility criteria's. Bid cost and Processing fee shall be payable online at the website www.jaipurmc.org. Bid Security shall be payable online in favor of "Commissioner, Municipal Corporation Greater Jaipur" payable at Jaipur in form of Bank Guarantee issued by any nationalized/ scheduled bank with validity of minimum 12 months or pay online at www.jaipurmc.org (scanned receipt of which is to be uploaded online at www.eproc.rajasthan.gov.in). The interested bidder may submit their proposals online along with a Non-refundable bid fee of Rs 500/- (Rupees Fivehundred only) towards the cost of Bid Document and RISL processing fee Rs 500/- (Rupees Five Hundred Only) both deposited in the account of Nagar Nigam, Greater Jaipur on website www.jaipurmc.org. The Scan Copy of receipt of online payment should be uploaded on website http://eproc.rajasthan.gov.in along with the technical bid cover.
- 2. Any other details or information can be received from the office of Executive Engineer (Project-I) in working hours in Municipal Corporation Greater Jaipur office, Jaipur.
- 3. Each bid must be accompanied by Bid Security Applicable in accordance with the provisions of "Rajasthan Transparency in Public Procurement Act 2012 &Rules 2013" website www.jaipurmc.org. NIB Document can be seen at or obtained from website http://sppp.rajasthan.gov.in. This notice and bid documents are available on following site: sppp.rajasthan.gov.in, eproc.rajasthan.gov.in. A complete set of bids can be downloaded from above mentioned website/s. Bid/s shall remain valid for 90 days (Ninty days) from the date of opening of the bid.
- 4 The empanelled agencies will have to deposit a performance guarantee as applicable in the form of bank guarantee. Any bid without cost of bid, bid processing fee and Bid Security deposit)/ bid declaration (as applicable) as in the NIB shall be rejected as non-responsive.
- 5. Bidder, who procured digital certificate as per IT Act 2016 to sign their electronic bids, shall submit their technical and financial offer online on above mentioned web site up to time and date mentioned herein above.
- 6. In addition to above, the scanned copies of the Original Documents should be uploaded along with the technical Bid/ cover:
 - i. Letter of Technical Bid
 - ii. Power of Attorney for appointing authorized representative
 - iii. certificate of registration in PF/ESI/GST and PAN Card is required
 - iv. All documents of Technical proposal check list enclosed should be duly filled
- 7. Contract document consisting of the detailed plans, complete specifications, the schedule of the quantities of the various classes of work to be done and the set of conditions of contract to be complied with by the persons whose Bid may be accepted, which will also be found printed in the form of Bids can be seen at the office of Executive Engineer (Project-I) every day except on Saturday, Sundays and public holidays, during office hours or it can be seen/ downloaded from web site http://sppp.raj.nic.in&www.jaipurmc.org
- 8. Bid Security deposit as per NIB is to be paid online in favor of commissioner Nagar Nigam Greater Jaipur at NNGJ website www.jaipurmc.org. No refund of Bid fees is claimable for Bids not accepted or forms returned or for Bids not submitted. / Each bid must be accompanied by Bid Security in accordance with the provisions of "Rajasthan Transparency in Public Procurement Act 2012 &Rules 2013".
- 9. If any Bidder withdraws his Bid prior to expiry of said validity period or mutually extended period or makes modifications in the rates, terms & conditions of the Bid within said period, which are not acceptable to the department or fails to commence the work in the specified period/fails to execute the agreement the department shall, without prejudice to any other right or remedy, be at liberty to forfeit the amount of Bid security given in any form absolutely. All Bids, in which any of the prescribed conditions are not fulfilled or which have been vitiated by errors in calculations, to taling or other

discrepancies or which contain over-writing in figures of words or corrections not initialed and dated, will be liable to rejection.

- 10. In case of any bidder fails to upload copy of Required Documents as mentioned in the bid document by respective bidder shall not be accepted. Any subsequent addendum/corrigendum shall be published only at the websites http://eproc.rajasthan.gov.in and will not be published in newspapers. In case there is a holiday on the day of opening of bids, activities assigned on that date shall be carried out on the next working day.
- 11. Before electronically submitting the bids, it should be ensured that all the bid documents including conditions of contract are digitally signed by the bidder. Nagar Nigam Greater Jaipur shall not be responsible for any delay in submission of bid in electronic form.
- 12. Department will not be responsible for delay in online submission due to any reason. For this, bidders are requested to upload the complete bid well in advance in time so as to avoid 11th hour issues like slow speed; choking of web site due to heavy load or any other unforeseen problems. The procuring entity reserves the sole right to cancel the bid process and reject any or all of the Bids without assigning any reason. Procurement entity disclaims any factual/ or other errors in the bidding document (the onus is purely on the individual bidders to verify such information) and the information provided therein are intended only to help the bidders to prepare a logical bid-proposal. No conditional bids shall be accepted and such bids shall be summarily rejected forthwith.
- 13. The provisions of RTPP Act 2012 and RTPP Rules 2013 thereto shall be applicable for this procurement. Furthermore, in case of any inconsistency in any of the provisions of this bidding document with the RTPP Act 2012 and RTPP Rules 2013 and Rules thereto, the letter shall prevail.
- 14. Nagar Nigam Greater Jaipur reserves the right to accept or reject any bid, or to cancel the bidding process and reject all bids, at any time prior to award of the Contract, without incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders on the grounds of Employer's action. The procuring entity reserves the sole right to cancel the bid process and reject any or all of the Bids without assigning any reason. All details relating to the Bid Document(s) can be viewed and downloaded from the website mentioned in NIT. Pre-qualification—Prequalification conditions, as applicable, are given in the Bid Data Sheet. Amendment to NIT, if any, would be published on website only, and not in Newspaper. At the time of submission of the Bid the eligible bidder shall be required to: pay the cost of Bid Document; deposit the Bid Security; Submit a checklist; and submit an affidavit.
