1. General Introduction

- (a) **BACKGROUND:** Jaipur, the state capital of Rajasthan and the one of largest city in India. As of 2011, the city had a population of 3.1 million, making it the tenth most populous city in the country. Jaipur is also known as the Pink City, due to the dominant color scheme of its building. It is located 268 km from the national capital New Delhi. Location and Connectivity Jaipur city is in the eastern part of the Rajasthan state. It is located at 26°55' N to 26.92°N latitude and 75°49'E to 75.82°E longitude. It has an average elevation of 431 meters. The city is located on National Highway No. 48 connecting Delhi and Mumbai. National Highway 45 links Jaipur with Kota and National Highway 21 links Bikaner with Agra passing through Jaipur. Jaipur city is connected by rail by all major cities of India. The administrative area under the Municipal Council Heritage Jaipur comprises of seven zones. A Council by a 100 Members governs it. The strategic geo-political location of NNJ, Heritage and its history is of great significance and hence the efficient functioning of the municipal body is of utmost importance locally and nationally. However, a floating population during seasons possess challenges for managing the civil services in NNJH area.
- (b) Disposal of Sanitary & Domestic Hazardious Waste became so essential as it causes magnifying impact on Environment and health of the citizens, if not disposed in scientific ways. Disposal of menstrual Sanitary Waste, emphasizing the segregation and collection of Sanitary Waste. Sanitary napkins and diapers must be separated, specially marked and sent for incineration/approved processing technology.
- (c) Nagar Nigam Heritage Jaipur has floated E-Bid for "Scientific Disposal of Sanitary & Domestic Hazardious Waste in Nagar Nigam Heritage Jaipur Area". Nagar Nigam Heritage Jaipur invites the suitable proposals from experienced firm for the disposal of Sanitary & Domestic Hazardious Waste in Nagar Nigam Heritage area. - (f) Site Trip: The Bidder is advised to Trip and examine the service area under municipal limits of NNJ, Heritage and obtain for himself on his own responsibility all information that may be necessary for preparing the bid and entering in to a contract.

(g) Signing Of Contract Agreement

i. The NNJH as applicable shall notify the successful bidders that this bid has been accepted, the bidder will then have to execute the agreement with NNJH. - a. "Corrupt practice" means the offering, giving, receiving, or soliciting, directly or indirectly, anything of value to influence improperly the actions of another party;
- b. "Fraudulent practice" means any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation;
- c. "Coercive practice" means impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
- d. "Collusive practice" means an arrangement between two or more parties designed to achieve an improper purpose, including influencing improperly the actions of another party.

8. Rejection of Bids: The bids are liable to be rejected if the Bidder

10. Rights of the Corporation: Nagar Nigam Heritage Jaipur reserves the right to suitably increase / reduce the scope of work included in this bid document. The Commissioner NNJ, Heritage at any stage can foreclose the contract without assigning any reason there of and the same shall be binding on the empaneled contractors.

11. Commencement of Work: The date of commencement of work shall be reckoned from the 7th day after date of issuance of letter of award.

12. Omission or failure to undertake the work: Omission or failure to undertake the work assigned to the contractor or if the contractor persistently neglects to carry out his obligations under the contract shall make the contractor liable for action. 13. If he fails to do so, his failure will be breach of the contract and the NNJH in its discretion without prejudice to any other right or remedy available in law may cancel the contract. The contractor shall also be liable for any pecuniary liability arising on account of any violation by him of the provisions of any statute. 14. Events of default Contractor's even to default

- (i) Despite previous warning from the Competent Authority, in writing, is otherwise persistently or flagrantly neglecting to comply with any of his obligations under the Contract;
 - (ii) The Contractor persistently fails to follow Good Operating Practices in execution of the Contract;
 - (iii) The Contractors to providing the operations and the stoppage has not been authorized by the Competent Authority;

15. Force majeure event: Any of the following events which is beyond the control of the party claiming to be affected thereby ("Affected Party"), and which the Affected Party has been unable to overcome or prevent despite exercise of due care and diligence, and result in Material Adverse Effect shall constitute Force Majeure Event:

- i. earthquake, flood, inundation and landslide;
- ii. storm, tempest, hurricane, cyclone, lightning, thunder or other extreme atmospheric disturbances;
- iii. fire caused by reasons not attributable to the Contractor or any of the employees, or agents of the Contractor.
- iv.
